About Special Issue

Ayurveda prioritizes diversified aspects of dietetics and nutrition and elaborates various dietary rules that are pivotal in promoting and preserving health. The recent surge of non-communicable diseases and escalation of infectious disease communicability has drawn the global population's attention to 'Ayush Ahara'.

In order to recognize India's age-old principles of Ayurveda and the Aahara prepared as per ancient texts, the Food Safety and Standards Authority of India (FSSAI) has formulated Food Safety and Standards (Ayurveda Aahara) Regulations, 2022 in consultation with the Ministry of Ayush and notified the regulations in the official gazette on 5th May 2022.

The strength of food technology and the availability of rich sources of knowledge of Ayurveda provide a novel horizon for inter-disciplinary and trans-disciplinary research. The application of technologies into traditional preparations may contribute to preserving nutritional values, increasing the shelf life of the food, enhancing the organoleptic and bioavailability attributes, etc. Integration of ancient and modern science will yield astonishing health outcomes.

Therefore, to identify the potential gaps and scope for future research in this area, CCRAS, is going to publish a special issue of JDRAS on "Ayush ahara".

The Special Issue will focus on manuscripts (Research papers, reviews, short communications, perspectives, book reviews and systematic reviews) related to Ayurveda, Yoga & Naturopathy, Unani and Siddha systems of medicine in the following areas:
